PROGRAM INFORMATION

- ☐ Required documentation: Photocopy of BC government issued ID which indicates permanent address is outside of Metro Vancouver.
- ☐ I have a documented physical or psychological condition that prevents me from using public transit.
- ☐ Required documentation: Completed Medical Exemption Request Form (available on the [Langara U-Pass BC website](https://www.langara.ca/upass)) if a valid form is not already on file.

IMPORTANT INFORMATION

- Completed form including all required supporting documentation must be received by **Tuesday, September 9, 2025**.
- Incomplete applications may result in the denial of a U-Pass exemption.
- Exemptions granted for any semester are valid only for that specific semester and will not be automatically carried over.
